I would like to thank everyone who helped with the Mini-HIMSS event. We could not do this with out you! Now, just wait until next year. :)







## **Health IT Certificate Program @ Columbia**



The federal government is promoting HIT and the deployment of electronic health records (EHRs) with monetary incentives for "meaningful use". This goal will require 51,000 new HIT professionals over the next five years. The goal of the Columbia University Certificate Program is to provide health informatics training which will provide the practical knowledge and skills required to use and implement EHRs in healthcare organizations.

### THE PROGRAM

Students will be provided a strong foundation in informatics concepts and develop the practical skills to assist commercial, clinical, and public health organizations comply with meaningful use criteria. The 6-month, competency-based certificate program offers a balance between providing a conceptual framework, background knowledge, and workforce skills.

#### THE CURRICULUM

Curriculum topics include: Project management, Organizational context for HIT, HIT implementation, User

interfaces, Health data exchange and security, Health information exchange, Knowledge representation, and Data storage. Optional lectures will address knowledge gaps in computer science or health care. The course culminates in detailed training in one of three workforce roles: Health Information Management and Exchange Specialist, Health Information Privacy and Security Specialist, or Programmer and Software Engineer

#### **COURSE FORMAT**

The course includes both individual learning and team-based activities to develop collaboration skills, a necessity for this multidisciplinary field. The majority of the course materials and activities will be available online, consisting of lectures, quizzes and case presentations. Teams, selected to maximize professional diversity, work together on case presentations and develop a capstone project, all of which are centered on real-world problems. Seven in-person Saturday sessions will be held at the Columbia University Medical Center campus. In-person instruction includes facilitation of team cases and projects in addition to lectures and demonstrations by industry leaders from clinical, pharmaceutical, and EHR vendor organizations.

#### **PREREQUISITES**

Students applying for this program will be expected to have at least a bachelor's degree with training or experience in a STEM (science, technology, engineering, or math) field, health care, or public health.
